The audit was performed as full annual audit at the TSP's location in *Ankara and Istanbul, Turkey*. It took place from *23/07/2019* until *26/07/2019* and covered the period from *03/08/2018* until *26/07/2019*. The audit was performed according to the European Standards "*ETSI EN 319 411-1, V1.2.2 (2018-04)*" as well as CA Browser Forum Requirements "*EV SSL Certificate Guidelines, version 1.6.8*" and "*Baseline Requirements, version 1.6.8*" considering the requirements of the "*ETSI EN 319 403, V2.2.2 (2015-08)*" for the Trust Service Provider Conformity Assessment.

The full annual audit was based on the following policy and practice statement documents of the TSP:
