These certificates of conformity have been obtained under LSTI PAD – ISO/IEC 30107-3 Certification Program, CLR Cert PAD – ISO/IEC 19989-3 Certification program and CLR Cert IAD – CEN TS 18099 Certification program.

The demonstration of the unique know-how of the InfoCert R&D team to match the defined requirements into these standards regarding liveness detection systems.
